

# Dynerics Privacy Statement

## 1. Introduction

Dynerics B.V. having its corporate seat in Best the Netherlands (hereinafter, together with its subsidiaries and affiliates, "Dynerics"), understands and respect the importance of your privacy. The purpose of this Privacy statement is to inform you of the ways in which Dynerics is processing your personal data. By 'personal data' we mean any personally identifiable information.

As of May 25th, 2018, the General Data Protection Regulation (GDPR) will take effect. This has an impact on the data protection notices Dynerics. This privacy statement for Dynerics' s corporate website is a requirement since Dynerics acquires data related to natural persons via this website.

When you visit this website and use it to subscribe to our newsletter we process your personal data. This privacy statement explains what types of data Dynerics acquires what it does with that data and your rights regarding the processing of your data by Dynerics. This privacy statement may be changed without ahead notice You are advised to regularly review the privacy statement for possible changes.

### 2.1. Types of data

Just like most websites, Dynerics or the provider behind the website of Dynerics, processes the IP addresses of visitors of its website.

In case you sign up for our newsletter, Dynerics processes some other personal data.

### 2.2. Purpose and processing of data

#### 2.2.1. Purpose

Dynerics processes your personal data for several purposes:

1. For the analysis of various aspects of visits, such as the location of visitors and what pages are viewed.

*To do this, Dynerics uses Google Analytics.*

2. To keep website secure and reachable, but also to comply with eventual legal obligations.

*Dynerics has secured this via their webserver provider. This provider works according to the ISO 27001 / NEN7510 method and is also compliant with the AVG / GDPR. They keep an overview of their personal data processing resources and the associated organizations. For this they take into account their own policy and the applicable laws and regulations. Every year this process is tested according to all their criteria and this includes the assurance of the AVG / GDPR.*

### 2.2.2. Website visits

As stated Dynerics uses Google Analytics services. Google Analytics uses analytic cookies. A data processing agreement between Dynerics and Google is in place. More information can be retained via Google.

### 2.2.3. E-mail notifications and newsletters

The Website offers you the possibility to subscribe to newsletters and e-mail notifications on subjects like events or press releases. If you decide at any time that you no longer wish to receive communications from us, please follow the unsubscribe instructions found at the end of every e-mail notification or newsletter.

The data you provide when filling in the contact form is accessible for employees of Dynerics.

By sending the form you give Dynerics your consent to process your personal data.

Dynerics is working with carefully selected third parties (like Atradius Credit insurance) that we may engage to perform services on our behalf, provided those parties agree to keep your personal data confidential and to process your personal data only on our behalf. We may also release your information when we are obliged to do so or when we in any way believe such release is appropriate to comply with the law.

If Your personal data is sent via the Dynerics website, Mailchimp collects your data, this information will eventually be combined with other personal information and stored in PerfectView software.

A data processing agreement between Dynerics, Mailchimp and PerfectView is in place.

### 2.4. Disclosure

Dynerics will not disclose your personal data to third parties without first obtaining your consent, if necessary, unless this is required for a declaration of offense or necessary for the purpose of the processing.

### 2.5. Storage

When you visit our website, Dynerics does not store your personal data longer than necessary for the purpose.
